

Centenary Celebrations

We recently received confirmation from The Lion that they have cancelled all social events for the rest of this year and therefore will no longer be able to host our 100th anniversary ball.

The committee are in the process of contacting other suitable venues and hope to have some updates for you regarding deposits and dates in the next bulletin if not before.

Government Guidelines

Members will be aware that there has been a considerable amount of movement in the Government's advice on the resumption of activities within the performing arts since the last bulletin. It is now possible for rehearsals and even performances to resume for both professional and amateurs but only with strict social distancing measures in place at all times for both performers, crew and audiences. Whilst professional productions may be able to put in place systems (such as isolated bubbles that undergo regular testing) to allow close contact on stage this does not apply to non-professionals under any circumstances and the current social distancing (i.e) 2m or 1m+ with mitigations such as face coverings) must be rigidly applied.

The Civic Theatre has informed us that they will not be reopening for audience attended productions until into next year and, when they do start, the audience capacity will be

limited to 150 making it economically unviable to put on a musical production, even for an amateur company. However, Young Gen are looking to re-open headquarters (following some extensive refurbishment works and adaption for Covid Secure protocols) and your Committee are discussing with them what CAODS might be able to do in the space.

As outlined in our previous bulletin, there will be protocols in place that will need to be followed by all participants but we will let members know the details of these in due course (as they have to be assessed and modified for each individual activity). As previously, the situation remains fluid in response to (now) rising levels of infection across the country (the Government has, from Monday 14th September for example tighten the restrictions on social gatherings). The DCMS Select Committee took evidence from the industry on 8th September. They have said that this will be passed back to Government Ministers for further consideration and we'll keep you updated as much as possible.
